E. ORDINANCES: FOR FINAL PASSAGE

1. Council File No. 16,579 Pending Official File Ordinance No. 1-2026
Amending [Ordinance](#) Number 26-1958, the Traffic Code of the City of Erie by the installation **stop signs at six intersections**. The City Traffic Engineer is authorized and directed to install appropriate stop signs at the following locations:

- 1) W 27th Street & Emerson Avenue – stopping W 27th Street
- 2) W 27th Street & Washington Avenue – stopping W 27th Street
- 3) Maple Leaf Drive & Pebble Drive – stopping Pebble Drive
- 4) Cold Spring Drive & Washington Avenue – stopping Cold Spring Drive
- 5) Cold Spring Drive & Melrose Avenue – stopping Cold Spring Drive
- 6) W 28th Street & Melrose Avenue – stopping W 28th Street

2. Council File No. 16,581 Pending Official File Ordinance No. 2-2026
An ordinance appropriating the sum of **\$742,429.00** from unappropriated and unanticipated revenue for the expenditure thereof from the City of Erie **ARP Fund** Interest and will be used to fund the **Capital Improvement Fund**.

3. Council File No. 16,582 Pending Official File Ordinance No. 3-2026
An ordinance amending Official **Ordinance No. 80-2005** known as the Zoning Ordinance of the City of Erie, by changing the classification and/or the rezoning of the property located at Hillcrest Avenue (Tax ID 18-053-002.0-303.00), which is adjacent to a property located at 4125 Peach Street.
